suffering, or death ("Harm").

I AGREE to release Boulder Pointe, Andrea Keacher from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted , directly or indirectly, from the

negligence of Boulder Pointe and Andrea Keacher

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Boulder Pointe and Andrea Keacher

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Boulder Pointe and Andrea Keacher and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused

by me or my horse at the Boulder Pointe Schooling Show.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions

and Agree to assume all of the obligations of this Release on the child's behalf.
